Interview Assessment

Adequacy of the host organisation and personal reasons	Max 8 points
Linguistic competence	Max 12 points

Applicants must fulfil the following requirements:

- TTMI and/or LCM students must have at least passed the Language 1 or Language and translation 1 exam in the language area for which they are submitting an application.
- LM94 and/or LM37/38 students must have specialised in the language of the destination country since their first degree
- Adequate linguistic skills subject to verification by the host organisation
- Must *preferably* have taken the "didattica dell'italiano L2" [teaching Italian] exam

Applicants will be assessed on the basis of:

- study curriculum (average)
- mandatory interview



The assessment will be scored out of sixty, with 50% determined by the average for the student's curriculum (if curriculum averages are equal, the average score for the language of the relevant country will be used) and 50% determined by the assessment made during the mandatory interview, according to the following criteria: Appropriateness of the organisation and personal reasons: max 8 points, Linguistic competence: max 12 points.

NOTES:

- Traineeships in organisations listed in the call normally involve tasks related to <u>teaching Italian as</u> <u>L2</u>.

- The UNIVERSITY OF WOLVERHAMPTON traineeship involves activities related to computational linguistics.

- The FRIEDRICH-ALEXANDER-UNIVERSITÄT ERLANGEN-NÜRNBERG only accepts undergraduate students for the Placement.

- For all the organisations listed, students are advised, in agreement with the respective Professors responsible for the exchange, to check with the assigned organisations whether the law in the host country allows a post-graduate Placement as well.

PLEASE NOTE: Students who have already benefited from an Erasmus scholarship (even during previous degree courses) without gaining credits, may submit an application, but priority will be given to candidates who have not yet participated in the programme and who have listed the same organisation as a preference.
